05.01.12 – 01 Cllr Faulkner produced an analysis of the 11 replies received from villagers to the Parish Council questionnaire, a copy of which is attached to these Minutes. The following responses were made/actions agreed by Councillors in respect thereof:

- Road Signs Parish Councillors will arrange to clean the road signs around the village;
- Overgrown hedges the Parish Council is vigilant on this issue and has no hesitation in contacting occupiers of 'offending' properties;
- Affordable Housing the Parish Council confirmed that it was aware of this issue and that planning permission for 12 affordable homes around the village is in place. The difficulty is attracting a developer to build the homes. Cllr Bartlett confirmed that he would approach Col Lee about this. Action Point 05.07.12 01; and

- Clarity about the Parish Council and its functions on this point, the webmaster for the village website has asked for photographs of Parish Councillors and it was suggested that an article about the Parish Council and its work could be prepared for posting on the website.
- **02.02.12 01** Quotations have been received, the total cost of which is £581.00. It was agreed that the works need to be undertaken and Cllr Faulkner was authorised to order the equipment and its installation.
- **02.02.12 02** Following a successful Diamond Jubilee weekend, the Parish Council agreed to contribute 50% of the cost of the activities laid on by the Community Council. The total cost for the mugs (£816.00), tablecloths and bunting (£135.00) and barbeque (£19.00) is £970.00. The Parish Council agreed the payment of £485.00.
- **05.04.12 03** Cllr Bartlett has been in contact with County Councillor Andrew Stringer who has agreed to contribute £336.72 (60%) from his 'Quality of Life' budget towards of the cost of 'cattle warning' and 'slow' signage on the B1077 outside Thorndon Hill Farm. The Parish Council agreed to pay the balance of £224.48, being the cost of the signage required as quoted to Cllr Bartlett by John Simpson at the Highways Department at Suffolk County Council. **Action Point 05.07.12 02**
- **03.05.12 01** Cllr Bartlett has spoken to Col Lee about the installation of signs for dog walkers using the set-aside land. Col Lee is aware of issues around dog mess, but not of any individual being bitten. In any event his attitude is that the set-aside area is a public place and it is the responsibility of each individual dog owner to control their dog/s. The matter cannot, in the circumstances, be taken any further.

- **7.3** Barclays Bank plc have written to the Clerk advising that following a review of their accounts they will close the Parish Council's account unless there is either a credit payment received or other movement on the account before 10.08.12. It was agreed to pay £2.50 into the account for the time being to keep it 'alive'.
- **7.4** A new code of conduct has been issued to accommodate the provisions of the Localism Act 2011. The Parish Council voted to adopt the new Suffolk Code of Conduct and Councillors were given the new Declaration of Interests Form for completion and return to the Clerk.
- **7.5** The Parish Council agreed to adopt its existing standing orders for the current financial year.

8. AOB and Meeting opened to the Public 21.20

- **8.1** In respect of the Diamond Jubilee celebrations, the Chairman thanked the public and Parish Councillors for their help with specific thanks to Hazel Wood who arranged the commemorative mugs for the children of the village.
- **8.2** Several Councillors wanted to acknowledge Cllr Theobald's book on the history of Thorndon which they feel is an excellent record and makes a valuable contribution to villagers understanding of Thorndon. In connection with this book, Cllr Theobald has experienced some unpleasantness from a member of the public. The Chairman confirmed that if any Parish Councillor experiences harassment of any kind it is a matter for the Police.
- **8.3** The 'Special Nature Reserve' signs cannot be seen as the grass is so long. Cllr Horton will liaise with Sue Hooton at MSDC to ascertain when the grass will be cut. **Action Point 05.07.12 03**

- **8.4** Robert Hunt has cleared the entrance to the set-aside land, and the Parish Council felt it appropriate to make a donation of £50.00 to him as an acknowledgement of his efforts around the village planting flowers and general tidying etc all of which make the village look attractive.
- **8.5** The continued presence of a skip in Fen View was raised. The matter has been brought to the attention of the Housing Department at MSDC who have written to the occupier. If the same remains in a week's time, Cllr Bartlett will pursue the issue with MSDC. **Action Point 05.07.12 04**
- **8.6** The issue of potholes in Fen View was raised. The advice of the Parish Council as set out in April's 'Village Life' was reiterated, namely individuals should take responsibility for reporting the same. The article in this regard will be repeated in the next issue of 'Village Life'.
- **8.7** Cllr Taylor confirmed his agreement to act as footpath monitor. The Clerk will advise MSDC accordingly.
- **8.8** Mr Brand delivered his report on behalf of neighbourhood watch.
