#### **6.1 Planning Applications:**

- **3825.12:** Revised internal accommodation and revision of fenestration to that approved under implemented Listed Building Consent 3829/10 at Barn adjacent to Hestley Hall, Hestley Green, Thorndon. The application was supported.
- **3784.12:** Continued use of former agricultural land as tennis court for private use (use having subsisted for the last 32 years), re-surfacing of tennis court and erection of replacement perimeter chain link fence to height of 2.75 metres at Green Farm, Hestley Green, Thorndon. The application was supported.
- **3785.12:** Erection of a two storey dwelling and detached garage and creation of new access at Cotes Cottage, Thwaite Road, Thorndon. Prior to the discussion of this application, Cllr Botwright had made application for the grant of full dispensation. This was granted, and the application supported.

**7.3** The precept was discussed with reference to the proposed budget circulated prior to the meeting. It was felt that an inflation based increase should be factored into next year's precept and the sum of £7,750.00 was proposed and unanimously agreed. This decision was made on the basis that there are no current projects being undertaken by the Parish Council but in the knowledge that the precept may have to increase at a rate above inflation in the near future as and when this situation changes. It was also agreed that ahead of setting the precept next year the Parish Council would endeavour the identify potential projects and the cost thereof in order that the same can be factored into the precept for 2014/2015.

#### 8. AOB and Meeting opened to the Public 21.10

- **8.1** The Councillor vacancy has been advertised on the Village Notice Board, but no one has contacted Mid Suffolk District Council requiring an election. The Parish Council can now co-opt a Councillor. The position will be advertised in the Village Life.
- **8.2** Cllrs Ravenhill and Bartlett had received an email from Craig Beach, an architect resident in Thorndon, who had noted the issue of social housing in Thorndon referred to in recent minutes. Mr Beach is working with the Metropolitan Housing Association, which is interested in facilitating self-build, eco communities of up to 8 houses. Although the planning permission at Kerrison would not be suitable for one of these projects, it was suggested that Mr Beach and a representative from the Housing Association be invited to attend a Parish Council meeting when their proposals were formulated in around six months to investigate possible collaboration. **Action Point 17.01.13 01**
- **8.3** Mr Brand delivered his report on behalf of neighbourhood watch.
