- **03.10.13 02** Cllr Bartlett has now spoken to both Fiona Sheldrake at Mid Suffolk District Council and John Simpson at the Highways Department at Suffolk County Council both of whom have been very helpful. A list prioritising the items requiring attention has been agreed and will be actioned accordingly.
- **02.01.14 01** Cllr Ravenhill has now received a letter from Thorndon Town Trust in which it advises that the Trust is unwilling to split its land into separate parcels as proposed by the Parish Council and is, therefore, unable to assist any further.
- **03.04.14 01** Cllr Hayward has now submitted an application and the Highways Department at Suffolk County Council has confirmed the application is 'on the list'. This item will now be removed until the result of the application is to hand.
- **03.04.14 06** Following the last meeting, District Councillor Tilbury followed this matter up and has been able to confirm that the owner of the Stoke Ash White Horse has been invited to submit an application for retrospective planning consent for the overflow car park to regularise the position. Whilst it would seem that both Highways and the planning department are happy with the development any objections to the same concerning visibility can be raised once the application is submitted.
- **01.05.14 01** Cllr Jenkins has now contacted John Simpson at the Highways Department at Suffolk County Council who have recommended laying granite stones to define the triangle, although any such undertaking would need to be funded by the Parish Council. Mr Simpson has indicated that the cost should be about £800.00 £1,000.00 for an edge 1 stone deep. However, in view of the movement of buses which have caused damage in the past, a surround 2 stones deep was mooted. Cllr Jenkins will now obtain a quotation of costs for further discussion. Any application for such works should be channelled through Mr Simpson who cannot envisage a problem with the same and County Councillor Stringer will investigate whether there is any possible funding available to assist with such a project.
