01.05.14 – 01 Cllr Jenkins has now received a draft estimate for the verge protection works to the Thwaite Road triangle from John Simpson (£650.00 if no closure required and circa £1,000.00 of road closure required) which has been circulated to Councillors. If the Parish Council is prepared to pursue this in the light of the costings, Suffolk County Council will provide a firm quotation for the works. A vote was taken agreeing to take this matter

- **03.07.14 01** Cllr Le Gros confirmed that he had looked at the telephone box and that it is working although the side panel is rather unsightly. It was agreed that the Clerk would lodge a complaint with BT requiring them to replace the panel or clean it. **Action Point 03.10.14 02**
- **04.09.14 -01** Cllr Hayward has contacted the Royal British Legion who have not received any offers of assistance for Thorndon. He will re-advertise for help in this month's Village Life.
- **04.09.14 02** Simon Woods has confirmed that he will volunteer as a grit shoveller.
- **04.09.14 03** Cllr Jenkins has spoken to John Simpson at Suffolk County Council who will arrange to send a sludge clearer to address this problem.
- **04.09.14 04** Cllr Bartlett has been in correspondence with Col Lea about his recent letter to the Parish Council. Col Lea has confirmed that the units at Kerrison are currently being marketed by Savills and Lacy Scott & Knight. There is a good level of interest in the site but no indication as to when completion of any sale may be achieved. In terms of the planning application no further action is to be taken pending a buyer being secured. The Parish Council will review this item at the meeting in December.

- **7.3.1** Following the hurricane last October and extended power cut which followed there were a number of elderly villagers who struggled to cope with situation. The Vicar has spoken to Cllr Ravenhill with a suggestion that the Parish Council and Church might get together and make some provision to assist villagers should a similar emergency arise in the future. The Parish Council agreed that this was a suggestion worth pursuing and Cllrs Ravenhill and Hayward will now liaise with the Church. **Action point 03.10.14 03 7.3.2** The Parish Council have agreed to review the Emergency Procedures Guidelines which
- **7.3.2** The Parish Council have agreed to review the Emergency Procedures Guidelines which have not been looked at for a number of years. Cllrs Farquhar and Le Gross will update the same for approval before publication in the Village Life. **Action Point 03.10.14 04**
- **7.4** The annual insurance is due for renewal and the renewal notice has been circulated to Councillors. It was agreed that the insurance cover is adequate for the needs of the Parish Council and that the Parish Council would avail itself of the lower annual premium offered by agreeing to the Long Term Undertaking for 3 years.
- **7.5** The new Post Office van is experiencing some difficulties securing a broadband connection necessary to operate the equipment. Whilst this problem is not unique to Thorndon the Parish Council feel it might be worth investigating whether anything can be done to improve the situation. Cllrs Bartlett and Ravenhill will pursue this. **Action Point 03.10.14 05**
- **7.6** A villager has enquired as to whether the Parish Council would consider a skateboarding facility at the Play Area. In the first instance it was agreed to ascertain whether there would be sufficient interest in such a facility. Cllr Hayward will place an article in the Village Life inviting interest in such a proposal before this suggestion is taken further. **Action Point 03.10.14 06**
- 7.7 Some 14 years ago flowering bulbs were planted around the village by the Community and Parish Councils for the Millennium. Inevitably some of these bulbs have died and need replenishing. It was agreed that Parish Council funds could be used to acquire replacement bulbs to a limit of £25.00 and in due course volunteer planters will be sought to assist ClIrs Ravenhill and Cattermole in this project.

8. AOB and Meeting opened to the Public 21.10

- **8.1** It was confirmed by District Councillor Tilbury that a planning application for the retention of the Stoke Ash White Horse Car Park has now been received by Mid Suffolk District Council. Several Councillors voiced disquiet about a lay-by which abuts the car park which is being used by HGVs and which then blocks the visibility splay at this dangerous junction with the A140. County Councillor Stringer suggested that anyone spotting parked vehicles at the lay-by should photograph the scene, forward the photographs to the Clerk for onward transmission to C Cllr Stringer who will pursue the issue with other authorities as parking within 30m of a junction is illegal.
- **8.2** Cllr Hayward confirmed that the survey by the Highways Department at Suffolk County Council is still awaited as the first step in of the application for a vehicle activated sign.
- **8.3** Cllr Farquhar identified a potential problem caused by two silver birch trees in Fen View whose leaves are blocking drains. The situation will be monitored
- **8.4** Mr Brand delivered his report on behalf of Neighbourhood Watch.
