- **03.10.14 01** Cllr Jenkins has received a response from John Simpson the cost of the works is to be £757.97, a sum approved by Councillors. The works are now being scheduled and it is expected the same will be undertaken in April.
- **03.10.14 02** Cllr Le Gros confirmed that the telephone is not working and consequently the number cannot be ascertained. The Clerk will write to BT advising them of this and stressing that BT must have a record of the telephone box in their asset legend and asking that the line be repaired in addition to the refurbishment of the box itself.
- **03.10.14 03** The PCC are meeting tonight and it is hoped that following this meeting this issue can be moved forward.
- **03.10.14 05** The box has now been fitted at The Black Horse and the Post Office van has been fitted with a power point. The connection has some bent pins which are causing some difficulties but it is hoped this issue will be resolved shortly.
- **06.11.14 01** Cty Cllr Stringer has no feedback to give but is actively pursuing this matter for both Thorndon and other Parishes in the same predicament.
- **04.12.14 01** Cllr Bartlett has drafted a questionnaire designed to establish the need for increased broadband connectivity in the village which will be circulated via the Village Life once the same has been approved by Cllr Ravenhill. In the meantime, Cllr Farquhar has secured Peter Ingram's consent to attend a Parish Council meeting for a Q&A session. Cty Cllr Stringer is to chase feedback on the data collated from the testing of telephone numbers around the village with which he has been supplied.
- **05.02.15 01** The Clerk read the response received from MSDC to her letter concerning the silver birch trees in Fen View in which MSDC reaffirmed its reluctance to prune the trees, inviting residents on whose properties the same are encroaching to undertake the work themselves. The Parish Council confirmed that it was not in a position to pay for the pruning and that the Clerk should revert to MSDC confirming that it was their responsibility to prune the trees and requesting that the works are now undertaken.
- **05.02.15 02** Cllr Bartlett has received an email confirming that an offer has been received for the sale of Kelly House, Old Chapel and Workshops. No further information is currently available.
- **05.02.15 03** Cllr Ravenhill confirmed that an order has been placed for a defibrillator. The box, at a cost of £540.00 + VAT, will be delivered shortly and the Ambulance Service will provide the defibrillator and training free of charge.
