- **13.10.14 03** Cllr Hayward confirmed that he has spoken with the Vicar, who is at a loss as to how this matter can be taken forward given the paltry response from villagers to the questionnaire placed in the Village Life. She feels there is still the potential for a centralised generator to be installed at either the Church or Village Hall. Cllr Hayward agreed to look into obtaining quotations for this.
- **06.11.14 01** Cllr Hayward has written to John Simpson asking for an update as to progress of the application, but has not received a response. It is felt there is no option but to wait for the application to be processed.
- **14.05.15 01** The Clerk confirmed that Cty Cllr Stringer has paid for the repair works to the Thorndon Triangle from his 'quality of life' highways budget.
- **14.05.15 02** The Clerk confirmed that she has received a full apology from the Planning Officer involved, who admitted that she had failed to note the extension of the accolaid system, as a result of which this was overlooked when she finalised the applications.
- **14.05.15 03** The Clerk read out both her letter to the Chief Fire Officer and his response, which in essence outlined the difficulties the Fire Service is currently experiencing in recruiting and retaining fire officers as a result of societal, technological and demographic changes over the past 5 decades. The Parish Council agreed to accept the invitation for the Area Commander to attend the next Parish Council meeting to explain the reasons for the reductions in fire engine availability, to highlight what steps are being taken to improve matters and to answer any questions from Councillors and villagers. **Action point 04.06.15 01**
- **14.05.15 04** Cllr Clinton confirmed that the two rotting posts have been replaced and that it will cost in the region of £2,700.00 to re-dress the car park, work which was last undertaken in 2008. This figure will be factored into the budget for 2016-2017.
- **14.05.15 05** Cllr Jenkins confirmed that he has concluded his audit of all road signs around the village and will now collate the data and refer the same to Suffolk County Council.

He acts for a client who owns the plot of land (0.6 hectares) adjacent to 'Whistle' Thwaite Road, which lies outside the settlement boundary. His client would like to erect two dwellinghouses on the land, keeping its natural features, including access, pond, trees and screening from the road. His attendance was an informal approach to the Parish Council to get its initial feedback on the proposal before a formal application for full planning permission is made. The Parish Council confirmed that whilst the draft proposals looked sympathetic to its environs, the fact that the proposed development is outside the settlement boundary would be an issue for the Parish Council. A query was raised about the access to the site, which was brought before the Parish Council some years ago, and which should be revisited if this application is taken further.
