4. Presentation by Mr J Howard

Mr J Howard has acquired part of the Kerrison site and attended the meeting to explain his proposals for redevelopment. He confirmed that a planning application for the creation of 28 residential units would be submitted next week of which 7 units will be newbuild and the remaining 21 will be created by the conversion of Kelly House and Old Chapel. Mr Howard confirmed that his emphasis was to provide smaller units suitable for first time buyers and confirmed that each unit would have sufficient parking. Mr Howard answered questions from both Councillors and the public and in so doing, confirmed that Mid Suffolk District Council, as part of the pre application process, has confirmed it is happy for residential redevelopment; that a sustainability study has been carried out as part of the application process and that ample access for current residents will be assured during the building works.

- **06.11.14 01** Cllr Hayward confirmed that he has still not received any response from Suffolk County Council regarding the Parish Council's application, although District Councillor Horn was able to confirm that he too has been pursuing this issue and has received an unofficial response that, essentially, the suggested sites are unsuitable. Cllr Hayward will pursue SCC to establish why he is not being kept informed on this application.
- **04.12.14 01**No details as to the timetable for the broadband upgrade have been received, and prior to the meeting the Clerk had an email exchange with County Cllr Stringer who is unable to attend the meeting in which he advised that he has asked for individual village appraisals, which are currently awaited. He will email the Clerk as soon as the same are received. Given the persistent delays on this matter it was agreed that Cllr Farquhar will invite Mr Peter Ingram, Programme Director of the Suffolk Better Broadband Programme to the meeting in November to host a 'Question and Answer' session. **Action Point 01.10.15 01**
- **03.09.15 02** The Clerk confirmed that she has spoken to Mrs W Coulson, Chair of the Board of Governors, who suggested that, rather than representatives from the Parish Council attending a Governors meeting, that a meeting be held at the school on 14 October next at 1.30 pm with the Head, Mrs Coulson, the Governor in charge of Health and Safety, two Parish Councillors and the PCSO who has attended the school to witness the problem. The letter confirms that where there is a local issue of concern to be discussed at a planned meeting or a police presence is required following a major incident than a representative will attend and that written reports on local crime issues will continue to be provided until the Constabulary's new website is launched in 2016.
