**02.06.16 – 02** Cllr Taylor confirmed that a provisional date for a meeting of 29 June next has been agreed with the landowner.

**08.09.16 – 03** Cllr Bartlett confirmed that, having spoken with John Howard, everything has been stripped out on site and the development has gone out to tender.

**03.11.16 – 01** Cllr Hayward confirmed that there have now been 2 meetings of the Neighbourhood Plan group. There are a lot of issues to consider and they are establishing which areas will take up most time. The first priority is to agree which planning area at which to look. Cllr Hayward has spoken to Paul Bryant, the Neighbourhood Planning Leader who has advised he has a team of assistants available to mentor groups such as this, who are reactive rather than proactive. Mr Bryant has also confirmed that there is funding available to assist with the external review once a proposed plan is available and to fund the staging of a referendum for the community. Thorndon School is perceived as a future major problem which will need to be considered by the Parish Council outside of the scope of the Neighbourhood Plan.

**05.01.17 – 01** Cllr Bridge advised that to date no response has been received from The Post Office but he will now follow this up in writing.

**02.02.17 – 01** It was confirmed that since works were undertaken here there has not been a sufficiently heavy rainfall to test the same.

**02.03.17 – 01** Cabinet 3, serving Fen View, is now enabled and ready for service. Cabinet 7, serving High Street, should be enabled in September.

**06.04.17 – 01** The Clerk confirmed that she has had an explanation from Mid Suffolk District Council advising that the initial notice of refusal had contained an incorrect address as the application site had no previous planning history and a new address had to generated by their Information Unit and it was incorrectly created. A revised notice showing the correct address was issued with the consent of the land owner.

**06.04.17 – 02** Cllr Farquhar noted that since the works were completed there has not been too much rain to test their effectiveness, although following a heavy downpour last week all surface water flowed away. It is a question of waiting for a more sustained period of rain to see whether the works have resolved the problem

**11.05.17 – 01** County Cllr Stringer advised that immediately prior to the launch of the new website many planning decisions were issued and this decision most probably got caught up in this flurry.
