- **08.09.16 01** Cllr Jenkins has spoken to one landowner about a blocked ditch in the village who readily accepts his responsibility but cannot afford to undertake the works.

In addition, the gulley which abuts the A140 is blocked. Cty Cllr Stringer confirmed that the problem was reported to Highways using the online reporting tool on 15 February last. Progress of the repair works can be followed online.

## 7.1 Planning Applications:

**7.6 Other:** The Clerk has received a letter from the Architect instructed by the owner of land lying to the north east of The Street Thorndon. In looking at the possibility of developing the site one issue which has arisen concerns access to the site. The Architect states that an easement over a slither of land owned by the Parish Council would be required and has asked for a meeting with representatives of the Parish Council to discuss the matter. Councillors stated that they are not prepared to entertain the grant of an easement over the land in question as a consequence of which they see no reason to meet to discuss the request. The Clerk will respond accordingly.

### 8. Specific Agenda Items:

The Clerk has received an email from a resident of Finningham whose car was damaged by a large pothole, the size of a football 5 inches deep, on the road out of Thorndon towards Stoke Ash. She is now processing a claim against Suffolk County Council for the damage. She enquired whether any other residents have encountered a similar misfortune and asking if her details could be forwarded to any such person or persons. Whilst Councillors are aware of the pothole in question no one was aware of anyone whose car had been damaged. This topic led onto a wider discussion on potholes and their repair. Cty Cllr Stringer advised that once a report of a pothole is made using the online reporting tool, the same is inspected by Highways who assess the timeframe for the need for the same to be repaired. Once this assessment has been undertaken, any legal action taken against Highways by a driver whose car has been damaged by that pothole within the timeframe, will fail. It is for this reason 85% of claims are rejected.

On a related topic, Cty Cllr Stringer referred to the recent questionnaire received by Parish Councillors from a Communications Officer at Highways

asking about whether Parish Councils undertake any works such as sign cleaning or cutting verges. The questionnaire was worded in such a manner that most Parish Councils thought the same was designed with a view to imposing obligations of such a nature onto Parish Councils. Apparently this was not the case, rather it arose following a fatality last year as a result of one of Highways sub-contractors and was an attempt by Highways to assess whether any training was required for Parishes.
