The Clerk questioned the payment of a whole days hire of the Village Hall for Thorndon History day (£120.00). Councillors confirmed that this was a legitimate Parish Council expense.

- **8.3** The Clerk has received a report from Thorndon Town Trust advising of the resignation of Mr J Coy and appointment of Mrs C Horton in his place. The new chairman will be decided at the next meeting. In the meantime requests from local students for donations for equipment to assist with their studies have been satisfied and a contribution to the village school made.
- **8.4** The Clerk mentioned an anonymous voicemail she has received expressing concern at street lighting at Kerrison. Councillors were unaware of such a facility but between now and the next meeting will inspect the site so the matter can be discussed in more detail in January. In the meantime the Clerk will revert to the caller inviting her to the next meeting to put forward her views.
- **8.5** The Clerk has received an email from the village tree warden querying whether or not the spinney at Kerrison was to become a building site. Councillors confirmed that this was not the case, and indeed, the spinney is not identified for potential development in the draft neighbourhood plan. The Clerk will respond accordingly.
- **8.6** The Clerk advised that she has received a copy letter sent by a villager to the Trustees of the Kerrison Trust concerning the lack of maintenance of the ditch along the north western boundary of Kerrison School field.
