#### 6. Planning

#### 6.1 Planning Applications:

**6.6 Other:** Mr S Page, the chair of the Thorndon Planning Committee, reported that the second Draft Neighbourhood Plan has now been completed it is planned to hold an event at the Village Hall to launch the statutory 6 week public consultation period with the Parish in 6 to 7 weeks. Cllr Hayward has confirmed that he has applied for final additional grant money.

The Pre-Submission Consultation is the public consultation phase noted in 6.6 above.

**8.1 Financial Update:** The current balance is £42,921.82 of which £10,120.29 are the grant monies received for the Neighbourhood Plan and the neighbourhood portion of Community Infrastructure Levy giving a net balance of £32,801.53.

# 8.2 Payments to be made:

**8.3** Councillors discussed the precept for the financial year 2020-2021. Based on expenditure for the current financial year of £14,000.00 and applying an increase of 3% in line with increases advised by SALC and Mid Suffolk District Council and factoring £625.00 for the new village sign cleaning contract and increase in Clerk's

salary, Councillors agreed to set the precept at £15,000.00. Noting that the Parish Council has over £30,000.00 in the account, it was agreed that any projects undertaken over the next year can be funded out of these monies.

**8.4** The Clerk confirmed that the next Parish Liaison Meeting will be held in Stowmarket on 4 February next. Cllrs Ravenhill, Hayward and Jenkins confirmed they would attend.

**8.5** The Clerk has received an email from Ms J Allen concerning the village sign cleaning contract advising that she is reviewing the quotation given 6 months ago and hopes to revert in time for the next meeting.

**9.1** Questions about the street lighting at Kerrison were raised. It was confirmed that the lighting is a planning condition. Cllr Hayward further confirmed that he has written to Mr J Howard, the developer, who advised that following a review of the concerns received, the lighting will remain in situ.

**9.2** Concerns about the damage to the verges outside the Bowls Club caused by parked cars were raised.

**9.3** Mr S Page suggested that the Parish Council might consider creating a path from the Church Car Park to make a safer route for staff from the School using the car park.

**9.4** Mr Brand delivered his report on behalf of Neighbourhood Watch.
