7.6 Other:

- Planning Consent DC.20.02052: Following the grant of planning consent for the erection of 3 poultry houses at Castle Hill Farm Cllr Ravenhill on the date of the last meeting, having had time to consider the consent and 20 conditions attached thereto feels that the Parish Council should write to the Planning Officer, Bron Curtis, to ask that she ensures that the Parish Council are notified as and when these conditions are satisfied. Accepting that there will be no consultation with the Parish Council as satisfaction of the conditions will be a matter of fact and not a matter for debate and fact that the Parish Council will, in normal course, be notified as and when the same are satisfied, Cllr Ravenhill considers it appropriate to write to the planning officer. She will draft a letter for consideration by Councillors.
- Neighbourhood Plan: Cllr Hayward has spoken to the leader of the Neighbourhood Plan Group at Mid Suffolk District Council who indicated the changes to the Neighbourhood Plan he requires. After referring the same to the Consultant, who suggested the same are acceptable, it is now expected that the Neighbourhood Plan will be put to Referendum in late July/August.

8. Specific Agenda Items:

8.1 3 Councillors were required to form a staffing sub-committee. Cllrs Hayward, Jenkins and Taylor were nominated and voted onto the sub-committee. They will meet before the next meeting when they will report back on the established terms of reference.

9.3 In anticipation of considering applications for co-option onto the Parish Council at the next meeting the Clerk confirmed she would circulate the same to Councillors when issuing the Agenda for the July meeting.

10. AOB and Meeting opened to the Public 20.57

- **10.1** Cllr Hayward advised that he has now identified the data SIM required for the CCTV system confirming that tomorrow he will purchase the same from O2 in Ipswich (the SIM not being available to purchase online). The expenditure (yet to be confirmed) was approved by Councillors.
- **10.2** Cllr Hayward referenced the significant increase in dog fouling around the village asking whether or not it would be sensible to erect signage requiring all dog owners to clean up after their dogs. Potential options were discussed and it was agreed that signs could have a beneficial effect. Cty Cllr Stringer confirmed that there are statutory provisions whereby, inter alia, a dog owner is breaking the law if they allow their dog to foul a public footpath.
- **10.3** Cllr Taylor advised that the fallen tree blocking the public footpath at Fen View should be removed by the landowner this weekend who, at the same time, will inspect another tree which is looking in need of attention. Cllr Taylor also advised that he has chased up the reparation works to the boardwalk.
- **10.4** Cllr Ravenhill referenced the forthcoming 'Plant a Tree for the Jubilee' project expressing the hope that the Parish Council would want to be involved in some way. Some ideas were proposed, including the planting of a small wood on the field behind the Play Area possibly involving the village school.
- **10.5** Mr C Brand delivered report on behalf of Neighbourhood Watch.
